2012 ADVISORY COMMITTEE MEETING MINUTES & RECOMMENDATIONS

March 1, 2012

The IESA Basketball Advisory Committee, in its meeting of March 1, 2012, makes the following recommendations to the Board of Directors for their April 13, 2012 meeting:

1. By-laws and Terms & Conditions changes/recommendations
 - a. 4.045: For regular season contests, student shall be limited to a maximum of **five (5) quarters** per day.
Students who participate on a school squad in basketball shall be limited to a **maximum of 110 quarters** in any one season, exclusive of the IESA tournament series. Participation in a quarter shall mean that a student actually competes (regardless of length of time) in a quarter of a game.
Rationale: *The additional quarter will help to facilitate the seasons of smaller schools. The recent trend has seen many schools dropping teams from the regular season and state series due to diminishing participation numbers. It is the hope of the Committee that the additional quarter will provide personnel for member schools that need to use 5th, 6th, and 7th grade students on their 7th and 8th grade teams.*
 - b. All basketball (boys and girls) to end the Saturday of week 36
Rationale: *The season for both boys and girls basketball was extended in 2010. The original purpose of this move was to allow for schools who did not participate in our traditional season an opportunity to participate in our state series. This has been confusing to both existing and new participating schools. I and the Committee would like to shorten up this time period.*
 - c. Add to the host instructions that the game times posted for all state series contests (regional, sectional, state) are the earliest time that a game would start.
Rationale: *Posted game times are the times that both fans and teams use to schedule travel. If games are being started earlier than the posted times, there is the possibility that both teams and fans will arrive late to the contest.*

Administrative Duties

1. Recording and Reporting of quarters:
 - a. Make up a sheet for each school to keep at the scorer's table. Include: some NFHS rules (halftime length, required numbers to start a contest), some IESA (quarter length, individual limitations, forfeiture of contest, mercy rule) rules, and how to keep a scorebook.
 - b. In the online rosters: add in a column on the roster for the total number of quarters for the season at that point per each individual.
 - c. As a resource for coaches: Use the volleyball lineup card and make changes for basketball and accounting for quarters.
 - d. Put in the initial mailing and emails reminders on what goes on your schedule and how long you should continue to update this information.
2. Add to the host instructions:
 - a. RECOMMENDED for Regional and Sectional hosts: Please provide adequate seating in the lockerrooms for athletes. If lockerrooms or adequate space is not available, please provide teams with classroom space and that this space may be secured. Please provide the warm-up or practice balls. Host school will be responsible for providing a scorebook. Please provide the participating schools with a list of the tournament officials as soon as they are set.
 - b. Recommended (State Finals): Lockerroom/classroom for each team and chairs (adequate seating) available in each of these rooms.
3. Initial basketball mailing: Put information on how you can access everyone's schedule, input sportsmanship ratings and officials ratings.
4. Talk to Craig about keeping the evaluation (officials and sportsmanship) open one week past the finals.
